Electricity Tariff Rise was political decision, say non-ruling parties

Representatives of four non-ruling parliamentary factions - Armenian Revolutionary Federation, Heritage Party, Armenian National Congress, and Prosperous Armenia Party - at a press conference on July 2 all agreed that the recent rise in the electricity tariff was as a result of a political decision.

Representatives of the four parties participated in yesterday's Public Services Regulatory Commission (PSRC) meeting and, according to Prosperous Armenia Party (PAP) MP Mikyael Melkumyan, presented reasonable arguments against the electricity price rise.

Melkumyan said that the Commission members and company heads made no counte arguments and voted unanimously in favor of the price increase. According to the MP, if things continue this way, the price of electricity will increase year after year. "The state might take these steps to mitigate [the problem], which is not in the professional, but in the political arena, and we witnessed this - the decision is only in the political arena," he said.

Head of the Heritage Party faction, Ruben Hakobyan, agreed, saying that yesterday's decision was political. According to him, the PSRC has succumbed to political decisions carried out by the ruling authorities. Hakobyan said their group of four non-ruling parties never opted for categorical rejection but took an alternative path, proposing solutions, and in this case too it will take similar action because it sees the existence of shady deals.

"You'll see, that which is being done — I'm refer-



ring to electricity becoming more expensive — doesn't have to be done, if only we are able to ensure transparency in how the system works. Yes, it's a closed space, there is no transparent gaze, for us to supervise what's happening here. This is against the law, and the quartet [the four non-ruling parties] is attentive in this matter," he said.

As a result of the electricity price rise, life will increase by about 10%, Hakobyan added. "No one denies this, and tomorrow we are going to witness this. Those 3, 4 months that we were thinking to give to the authorities, the authorities understood completely differently and, taking advantage of this continued on page 5

No need to apply to CSTO over situation at Azeri border: Armenian DM

The Armenian army is capable of solving the issue of tension at the border, and there is no need to apply to the CSTO, Armenian Defense Minister Seyran Ohanyan told reporters on the sidelines of the international strategy policy forum on "The integration of national and regional peacekeeping capacities into the global system of peace operations based on the principles and standards of the UN."

He added, however, that the CSTO could react to the situation with a statement specifying who violates the cease-fire

Speaking about the situation at the Armenian-Azerbaijani border and the line of contact with Nagorno Karabakh, the Defense Minister said: "The situation at the border and the line of contact is always tense: it's the number of shots increasing or decreasing. The number of shots and ceasefire violations has increased in the recent period. I think this is connected with political or other issues. Azerbaijan was recently celebrating its Army Day."

According to Seyran Ohanyan, there have been no subversive acts, just sniper shooting, and our border guards have given an adequate response.

Putin ratifies cooperation agreements with Armenia



Russian President Vladimir Putin has signed laws on the ratification of two cooperation agreements with Armenia and a treaty on good-neighborly and allied relations with Kazakhstan. The documents ratified earlier by Russia's lower and upper houses were posted on the official web portal for legal information on June 30, the Voice of Russia reports.

They include an agreement between Russia and Armenia on military and

technical cooperation, signed in Armenia's capital, Yerevan, in June last year and regulating mutual military supplies for the two countries' armed forces, law enforcement agencies and security services. Under the accord, Russia and Armenia will maintain military deliveries under contracts made by the two sides' designated institutions without the need for import/export licenses.

The president also signed a law on ratification of an intergovernmental agreement with Armenia on cooperation in commodity supplies to the South Caucasus Republic. The document signed during Putin's visit to Yerevan in December last year, stipulates Russia's duty-free supplies of petroleum products, natural gas and natural uncut diamonds to Armenia before the later joins the Eurasian integration space based on the Customs Union of Russia, Belarus and Kazakhstan.

break, are forcing such decisions on the people. If the authorities are using this political break to force these decisions on people, then we will give an adequate response to the authorities in the fall," he said.

Secretary of the Armenian National Congress (ANC) faction, Aram Manukyan, said the authorities were confident that the Commission would vote in favor of increasing the electricity tariff. "They knew 100% that [PSRC Chair] Robert Nazaryan's Commission will vote quietly, and all voted facing downward. It's a fact that the decision was political. This time our arguments were both political and financial," he said, adding that the PSRC is meekly carrying out the authorities' orders and is not an independent body.

Armenian Revolutionary Federation (ARF-D) MP Armen Rustamyan, in turn, said that the ruling authorities identify any situation that evoke issues that have social or political resonance with bankruptcy. He said that we are witness to a collapsing economy, adding that the authorities have a need for financial resources, for which there are two sources: "The first source is to extort from the people, which is possible, what remains; the other is acquiring debts from abroad. We don't need brains to understand this...We have an energy system that should've become the driving force behind the economy, but this system is losing its power. We've been an energy

exporter, but this too is under attack because it turns out that we get energy "Similar promises were made after the price of [natural] gas increased, but they



from Georgia. So there's a need to save the economy. Also, the body regulating public services is not carrying out its role, not taking its steps, [fulfilling its] functions, and so there are grounds to appeal to the Constitutional Court, in terms of revealing shortcomings in the law. What would've been better is if the vote was postponed, but there was an order from above," he said.

As for Armenian President Serzh Sargsyan's statement made on July 2 that the assistance should be provided to socially vulnerable families to ease the burden of the electricity price rise, Manukyan said it's an empty promise.

didn't carry them out. This is [...] an empty promise and won't be implemented, and even if it is, it won't solve anything because it can't stop inflation; it can't effect the drop in [consumer] purchasing power," he said.

Hakobyan said he has the impression from Sargsyan's statement that the latter found out about the electricity price increase only the day before. According to him, the state assistance to poor families is simply a tactical move — it won't solve the problem.

Rustamyan added that by saying "below poverty line" they understand different things. "When we say below the poverty line, we imagine that to be those who have an income less than the minimum budget. But for them [the authorities], it's something completely different. For us, 70% of the public is below the poverty line because it doesn't make the minimum income," he said.

The four non-ruling parties, Manukyan said, haven't come to a decision on the electricity price rise, but they're convinced that the electricity tariff doesn't have to be raised. "We want to convince the authorities not to increase the rate because it will lead to emigration, to inflation. Perhaps, it's hopeless optimism, let's convince them to step back from this issue, but we don't plan to lash out at them."





Davutoglu's scales are wrong, Turkish publisher says in Yerevan



"Genocide means not only the extermination of the nation, but also its generations, culture, traditions, cities and villages, and this is what happened in Turkey," famous Turkish intellectual, publisher Ragip Zarakolu told reporters in Yerevan today. He has arrived in Armenia to participate in the presentation of the Turkish edition of the "Armenian Genocide in Ottoman Turkey: Testimonies of the Survivors."

In 2012 Van publishing house issued the three-volume work titled "Armenian Genocide in Ottoman Turkey: Testimonies of the Survivors," which presents eyewitness accounts of the Genocide, valuable archive documents, maps and photos. In 2013 the book was published in English, and now it's available in Turkish, as well.

"I was greatly excited by the content of this book, because it includes interviews made in 1916, i.e. immediately after the Genocide. This is a very valuable document against Turkish denialism," Zarakolu said.

"This is denialism: once you lie, you have to do that constantly. This is Turkey's policy, which I have long been fighting against," he said

Zarakolu and his wife have been persecuted in Turkey because of their activity. He has published a number of books on the Armenian Genocide, and this one will come to enrich the list of banned literature in Turkey. "Thanks God there is Internet, and the book will reach the reader," the publisher said.

Zarakolu said much has changed in Turkey over the past years. "People are tired of lies, they want the truth," he said.

Ragip Zarakolu referred to Turkish Prime Minister Regep Tayyip Erdogan's address to the Armenian people on the eve of April 24 and Armenian President Serzh Sargsyan's invitation to the Turkish leader to visit Yerevan on the 100th anniversary of the Armenian Genocide. He also spoke about the recent article by Turkish Foreign Minister Ahmet Davutoglu, in which the latter notes that 'unjust memory has been created around the events of 1915.'

"Davutoglu's scales are wrong," the publisher said. "If we look at the period from 1915 to nowadays, we'll see that two million Armenians living in Western Armenia do not live there any more. Had there been no genocide, there would be 8-10 million Armenians living there."

Ruben Safrastyan: Instability in the Middle East fraught with unpredictable consequences



30-40 Armenian families fled to Armenia after the events in Kessab; most of them have now returned to Syria, member of the Public Council, Director of the Armenian Philharmonic Gagik Manasyan told reporters today.

According to him, other Syrian Armenians also intend to return to Syria after the domestic political situation in the country stabilizes.

"Although the Turkish-Syrian border is fully controlled by the Syrian troops and the security is ensured, the threat is still there," Director of the Oriental Studies Institute of the National Academy of Sciences Ruben Safrastyan said, in turn.

"Incumbent President Bashar Al-Assad's victory in the presidential elections and the success of the Syrian Army on the battlefield contribute to the normalization of the situation in the country," Safrastyan said. He added, however, that two other state formations are being shaped. The Islamic State or Caliphate was recently proclaimed on some areas of Syria and Iraq, while Kurds in the north of Iraq intend to create the Kurdish State.

According to Safrastyan, in reality the caliphate is a terrorist state, which functions under the flag of Islam and unites Sunni Muslims. If the political scientist is concerned about the caliphate, he's more optimistic about the perspectives of establishment of Kurdistan. He said it's an expected and an inevitable development.

"The West has to reconsider its attitude towards the Middle East, otherwise the instability is fraught with unpredictable consequences," Safrastyan said.

World Bank further strengthens power supply reliability in Armenia

The World Bank Board of Executive Directors today approved a US\$40 million loan for the Additional Financing of the Electricity Supply Reliability Project for Armenia. Thisadditional financing would scale up activities to enhance the impact of the ongoing project and cover the cost of rehabilitation of three substations essential for Armenia's power transmission network the Haghtanak, Charentsavan-3,and Vanadzor-1 substations.

The average age of Armenia's power transmission assets is around 45 years and most of them have not undergone any major rehabilitation or upgrade over the past decades. The ongoingElectricity Supply Reliability Project has been designed to enhance the reliability of the power supply in the country by improving the capacity of the power transmission network back-bone infrastructure. Around 230 km of outdated transmission lines from the Hrazdan Thermal Power Plant to the Shinuhayr substation is under replacement. The investments will increase the capacity and reliability of the targeted section of the transmission network by

lowering frequency of line failures and related power supply outages.

"The rehabilitation of the targeted substations will improve power system efficiency and reliability, and bring direct benefits to all power consumers in Armenia," saidJean-Michel Happi, World Bank Country Manager for Armenia. "This would allowavoiding increased incidence of power supply outages, as well as associated significant social and economic costs."

The new financing is targeting the assets that have a high priority in the list of investment needs. The Haghtanak substation requires rehabilitation and extensionand is critical for ensuring reliable power supply to distribution substations and consumers in the western parts of Yerevan. Charentsavan-3 and Vanadzor-1 serve residential and large industrial consumers in the north-easternand northern Armenia. Charentsavan-3also functions as switching stations linking to other six substations

Rehabilitation and extension of the three substations need to start as soon as possible. Several key sections of plant and equipment are well beyond their economic life and their increased incidence of failurecouldhave significant negative implications. In particular, some of the substations have equipment that was commissioned back in 1930s and have never undergone any rehabilitation since then.

"The capacity of the High Voltage Electric Networks (HVEN), which remains the implementing agency for this operation, has been strengthened under the ongoing project,"said Arthur Kochnakyan, World Bank Task Team Leader of the Project."This is essential to ensure the efficient implementation and sustainability of the new investments."

The project builds on the World Bank experience and draws extensively upon the lessons of previous engagement in the power sector of Armenia, as well as on transmission projects implemented in other countries.

Total financing of the project is US\$50 million, of which US\$10 million will be the Government's contribution. The World Bank will provide a US\$40 million IBRD loan of variable spread with a 10 year grace period and the total repayment term of 25 years.

World Bank Supports Improvement of Armenia's Investment and Export Promotion Services

WASHINGTON, July 2, 2014 - The World Bank Board of Executive Directors today approved a US\$50 million loan for the Trade Promotion and Quality Infrastructure Project for Armenia. This project is designed to strengthen the government's capacity to promote exports, attract foreign and domestic investments, and enhance quality services to business expansion.

Armenia has a relatively low export base, dominated by a few products with low value added content, reflecting the declining sophistication of its export sectors. The country also needs to step-up private investments, notably foreign direct investment (FDI). Left unchanged, the current structure of export basket will do little to mitigate the country's vulnerability to global competition and will lead to a lower growth trajectory. In addition, Armenia's national quality infrastructure suffers from substantial weaknesses that hinder technology upgrading and undermine the competitiveness of its exports.

"Trade is a key driver of growth in the transition to high income. This project will supportpolicies and programs aiming at upgrading Armenia's physical, human and institutional assets which are crucial to sustained export competitiveness," said Jean-

Michel Happi, World Bank Country Manager for Armenia."Raising long-term economic growth requires that the government tackle binding structural constraints to investmentand exports."

The project will specifically help: (i) improve the effectiveness of the trade promotion and quality system in Armenia; (ii) promote investment and exports by providing services to improve the capacity of local exporters to compete in foreign markets, facilitate cluster development, and attract efficiency seekingFDI; and (iii) modernize the national quality infrastructure by updating the metrological, accreditation and standards services to provide relevant quality management services to industry.

"To boost exports and FDI, Armenia needs a strong institutional framework," said FeyiBoroffice, World Bank Task Team Leader of the Project. "The project is designed to provide adequate incentives to enhance effectiveness of the government in delivering trade promotion and quality infrastructure services to firms."

The projectwill transform the investment, export promotion, and quality infrastructure agencies into modern service providers operating in accordance with international best practices. The proposed activities will support reforms to improve the relevant agencies and provide complementary investments for establishment of foreign representatives in key export and investment markets and the renovation of a metrology building and laboratories. As a result, it is expected to increase the capacity of firms to compete in export markets, facilitate public-private partnerships, and support the National Institute of Metrology and National Accreditation Board to obtain multilateral agreements with international bodies.

The project's direct beneficiaries include both existing and potential exporters, who will benefitfrom improved service delivery under a more efficient trade promotion and quality system. Foreign-owned firms that are going to invest in Armenia will also benefit, as well as local enterprises which will receive positive spillover effects from foreign direct investments. Furthermore, by promoting industry-academia collaboration, the proposed activities will largelyassistuniversities, research institutions and enterprises.

Total financing of the project is US\$59.54 million, of which US\$9.54 million will be the Government's contribution. The World Bank will provide a US\$50 million IBRD loan of variable spread with a 10 year grace period and the total repayment term of 25 years.

Jordan could be the Islamic State in Iraq and the Levant's next target

Summary

The Islamic State in Iraq and the Levant, buoyed by its recent successes in Iraq, wants to expand its regional reach. Reports that Iraq has withdrawn forces from western towns close to its 180-kilometer (110-mile) border with Jordan have left Amman feeling vulnerable, and the Hashemite kingdom, certainly a target of interest for the jihadist movement, has deployed additional security personnel along the border.

However, taking on Jordan would be tough for the Islamic State in Iraq and the Levant. The group has the ability to stage terrorist attacks in the country, but significant constraints will prevent it from operating on the levels seen in Iraq and Syria.

Analysis

The June 15 edition of the Jordan Times reported that Amman had beefed up security along its border with Iraq amid fears that the Islamic State in Iraq and the Levant is inching toward the kingdom. Quoting unnamed Islamist sources, the report added that the jihadist group had established a branch within the kingdom as part of its plans to create a regional emirate.

The militant group's intent to expand into Jordan follows the region's geopolitical logic. After its push into Iraq, and already controlling significant swathes of Syrian territory, the jihadist group can try to push into the Hashemite kingdom from two directions. Jordan is the only opening available to Islamic State in Iraq and the Levant -- the group cannot move north into Turkey, nor could it move southwest into Lebanon. Even in Jordan, though, the group faces considerable challenges.

For starters, the Jordanian regime is far more stable than Syria or Iraq, and its security forces have proved to be quite effective. Furthermore, Jordan has strong backing from the United States and Saudi Arabia, especially since the kingdom became a critical staging ground for support to Syrian rebels. Washington and Riyadh can extend financial, intelligence and military assistance to Amman. But Jordan is also a key sanctuary for rebels, and this aids the Islamic State in Iraq and the Levant's cause.

Jordan has long had a substantial Salafist and jihadist presence. Since the start of the civil war in Syria, jihadists have moved frequently across the Jordan-Syria border. Amman has tried to crack down on this crossborder traffic, but it has not brought it to a

Jordan is the native country of Abu Musab al-Zargawi, the slain founder of the organization that later became the Islamic State in Iraq and the Levant. However, the kingdom's

jihadist landscape is currently dominated by forces that oppose the group and are aligned with al Qaeda and its Syrian ally, Jabhat al-Nusra. Though the Islamic State in Iraq and the Levant has its own supporters in Jordan, the best-known jihadist ideologues in the country -- people such as Abu Muhammad al-Magdisi and Abu Qatada -- have criticized the group, especially its revolt against al Oaeda prime, creating dissension within jihadist ranks in Syria.

The Islamic State in Iraq and the Levant's jihadist opponents are dismayed by what they see as the group's high-risk maneuvers, such as its mass killings of Shia and its insistence on imposing austere Islamist laws in the areas it controls, actions that risk alienating locals in a given country. In September, al Oaeda leader Ayman al-Zawahiri issued guidance specifically addressing the issue, calling on jihadist fighters to refrain from fighting sects, such as Shia, Ismailis, Qadianis and Sufis, unless elements from those sects begin the fight. He similarly called for noninterference with Christian, Sikh and Hindu communities living in Muslim lands. He also ordered jihadists not to target noncombatant women and children or fellow Muslims via explosions, killings, kidnappings or destruction of property.

Turkey's Declining Support in Congress After Blunders at Home and Abroad

Due to Prime Minister Erdogan's widespread human rights abuses of his own citizens and foreign policy blunders vis-a-vis Armenia, Cyprus, Egypt, Greece, Iran, Iraq, Israel, and Syria, Turkey has lost much of the support it once enjoyed in the United States, and indeed, around the world.

The most recent evidence of this downturn is the adoption of House Resolution 4347 (Turkey Christian Churches Accountability Act) on June 26 by the Foreign Affairs Committee. Because of souring relations between Ankara and Washington, the U.S. Government refrained from spending its political capital on the Hill to prevent the bill's passage.

In addition, inter-Turkish feuds such as the one between Erdogan and Fethullah Gulen, a Turkish cleric with extensive influence in Turkey and abroad, have deprived Ankara of important grassroots support in the United States. Gulen-affiliated groups did not lift a finger to bail out Erdogan's government from a humiliating defeat in the Foreign Affairs Committee.

Due to another internal political dispute, the Turkish Coalition of America refused to sign the joint letter sent by three other Turkish-American groups to House Committee members opposing the Churches bill. In a desperate search for supporters, the Turkish groups recruited to their lobbying efforts the Azerbaijan American Council, which has no business sticking its nose in a matter involving the status of Christian churches in Turkey. By signing such a hostile joint letter, the Azeri group further antagonized Armenians worldwide, making it more difficult to reach a fair settlement in the Karabagh (Artsakh) conflict.

Finally, the Turkish government's clash with Israel after the Mavi Marmara attack and Turkey's new Ambassador Serdar Kilic's recent angry letter to the American Jewish Committee for recognizing the Armenian Genocide deprived Ankara of any lobbying support it used to receive in Congress from the Israeli government and some Jewish-American organizations.

In the absence of all support from its traditional allies, the Turkish government could only rely on its hired guns -- highly-paid US lobbying firms -- implement the standard Turkish tactics used in opposing any initiative that Ankara deems to be against its interests:

- 1) Object firmly to any anti-Turkish initiative to prevent its consideration;
- 2) If step 1 does not work, propose amendments to dilute the initiative;
- 3) Even after diluting the initiative, pressure the committee members to vote against it

In the case of the churches bill, the Turkish government failed to block its consideration by the House Foreign Affairs Committee and was unable to collect enough votes to defeat the measure. The only thing left for Ankara to do was having some members of the Congressional Turkish Caucus to propose amendments to dilute the bill. This tactic had a modest success because Cong. Ed Royce (Rep.-CA), Chairman of the House Foreign Affairs Committee, tried to reach a consensus on the bill and went out of his way to accommodate the handful of dissenting members of Congress. After all, who in their right mind would oppose a bill that called for the return of religious properties to their proper owners which happen to be the Christian churches!

This is the second major defeat that Turkey suffered in Congress in the last three months. The Senate Foreign Relations Committee had adopted an Armenian Genocide resolution with a vote of 12-5 on April 10 -- a further indication of the declining Turkish political clout in Washington. One simply needs to read two recent articles in the New York Times ("After Opening Way to Rebels, Turkey is Paying Heavy Price") and the Wall Street Journal ("An Unhelpful Ally") to see the degree of damage Erdogan has caused to his country's reputation.


In addition to the loss of clout, the Turkish government is wasting the millions of dollars it pays each year to high-powered, but apparently useless American lobbying firms that make big promises, pocket large amounts of money, and deliver practically nothing. When will the people of Turkey demand an account from their corrupt and irresponsible leaders who are throwing away Turkish citizens' hard earned tax dollars in a vain attempt to whitewash their genocidal history?

Pundits are predicting that despite Prime Minister Erdogan's dismal record both at home and abroad, he is expected to be elected president next August. Armenians, Greeks, Kurds and other oppressed ethnic and religious minorities are only too happy to see Turkey ruled by an incompetent leader who will bring the country to its knees!





The Armenian identity in France in the grip of memorialization

A year now from celebrating the centenary of the 1915 Genocide, the large Armenian Diaspora of France has made a priority of the "memorial duty" and the fight against revisionism at the expense of reflecting on their very future and lasting presence.

Four generations have succeeded the first wave of refugee survivors of the Genocide who ended up settling along the Paris-Lyon-Marseille axis in the 1920s. Formerly at the forefront of political activism in the Diaspora, the Armenian structures of France are now plagued by a general sclerosis, whose effects became apparent in the mid-1990s.

Continuous assimilation

Published in 1986, Pastor René Léonian's study Are the Armenians of France Assimilated? indirectly questioned how lasting an identity could be when challenged by the integrating framework of the French Republic. Two years later, the outbreak of the Karabakh conflict and Armenia's independence briefly altered a set identity pattern by causing a momentary resurgence of the dramatic sequence of armed struggle of the late 1970s. But although the word Armenian has eventually entered the French national story - notably through Missak Manouchian's accomplishments1 or the work of singer Charles Aznavour – the naturally-assimilating French society produced logically "Frenchmen of Armenian stock" as opposed to the tiny defiant group defining themselves as "Armenians of France."

Armenians: how many subdivisions?

Whether you claim to be part of a 350,000 or 500,000 member strong community, figures are unverifiable because of a widely-disseminated population. Like other communities of the Western Diaspora, the immutable commemorative gatherings of April 24th which are held in towns with clusters of Armenian population offer a much too limited view of its demographic dynamism. Another illusion is that there is any sense of cohesion between the various segments of the community. In reality, it is very divided, due to the social and cultural splintering of a heterogeneous population. Since the 1920s, several strata of immigration have aggregated: the generation of survivors of the 1915 Genocide followed, at the end of the 1960s, by Armenians from the Middle East (Iran, Syria, Lebanon, Turkey). The latter, who carried a strong Armenian cultural baggage, engaged in the various community organizations, particularly at an educational level, bringing a new dynamics to the waning practice of the Armenian language, weakened by its loss of speakers. The last wave, from the former Soviet Republic of Armenia, is still on-going. It started in the mid-1990s, the outcome of economic emigration, and is characterized by little involvement in community life and by inspiring distrust or even scorn in most fellowmen from Armenian-Ottoman origins.

Political crisis

A year now from centenary commemorations of the Genocide, which have been entrusted to the staff of the Coordination Council of the Armenian organizations of France (CCAF), the crisis is obvious. Founded in 2001, that representative body bringing together the whole rainbow of Armenian associations still finds it hard to unite around a common project reaching beyond the sole memorial function. A telling failure was the floundering of the French-Armenian Council, an ambitious project relying on the legitimacy of universal suffrage which, for the first time, made future

leaders of the community accountable to their constituents and their results judged by the ballot box. Although the idea had garnered support from most of the community leaders, it quickly fizzled out in the midst of general indifference – as if the elusive "Armenian constituency" could only express their interest in a common cause on very rare occasions – such as, at best, to shout their indignation in the face of genocide denial.

Another aspect of political deficiency is a form of mimesis. French-Armenians have always felt a complex mix of admiration and envy regarding the cultural, economic, intellectual and political dynamism of the Jewish community of France. Very few public figures of Armenian descent reach such clout and visibility in the French media. This is why the CCAF leaders decided to mimic counterpart, the Représentatif des Juifs de France (CRIF), going as far as to copy their famous annual high-profile Paris dinner. Although the "solidarity between survivors," as goes the famous phrase coined by controversial philosopher Bernard-Henri Lévy, appealed to Armenians, the Judeo-Armenian convergence has hardly gone beyond a purely emotional level.

The perverse effects of the "duty to remember:" the 2015 syndrome

Impatiently awaited by some, feared by others, the centenary commemorations of the Genocide as seen from France remarkably illustrate the prominent place taken by the devoir de mémoire (duty to remember) compared with other features of Armenian-ness, making the Genocide the most powerful de facto identity marker. For many French people of Armenian descent, this centenary will be a last send-off, the Armenian identity being often perceived as an inherited psychological burden. It will also be an opportunity for flights of imagination. It was thus suggested to have all the bells of the churches of France ring together on April 24th 2015 at 7.15pm. In the same spirit, an organization called "Courir pour la mémoire stop au négationnisme" (Run for Memory - Stop Revisionism) intends to climb the Everest "to deliver a message of peace and remembrance"... Could too much remembering kill the memory? Many French towns counting a few Armenian residents have installed their own khachkar (funeral headstone with the Armenian cross) dedicated to the memory of the victims of an unspeakable crime. Memorial centres were inaugurated in Valence, Décines, and one will soon open in Paris. And the former prestigious Mekhitarist lyceum in Sèvres, outside Paris, now only the shadow of its former self, intends to open its own Genocide museum.

For lack of a coherent vision of the future of Armenian identity in France, the leaders of the main French-Armenian organizations are staking everything on the strong media coverage of the 40-year struggle for recognition of the Genocide. Although some breakthroughs were achieved in the academic world and the media, one cannot ignore the current stalemate and perverse effects due to the mostly defensive posture of activists faced with mounting attacks from Turkish-Azeri nationalist organizations operating in France. Besides, it is to be feared that too much focusing on the memorial effort will exacerbate dissenting voices of people who think that the Armenian cause also means to invest more energy in the development and security of Armenia and Karabakh, in fighting the oligarchic excesses of the Erevan government, as well as in educating new elites of the Diaspora.

Spiritual crisis

Another symptom of the current cultural dereliction is the lack of investment in grey matter. The conditions that led to the closure of the illustrious daily newspaper Harach2, in 2009, have been experienced as a third-class burial of a whole school of thought born of the Diaspora and which bloomed into great names of the Armenian literature of exile such as Shahan Shahnour, Nigoghos Sarafian, Zare Vorpuni or Vasgen Shushanian. A great witness of that golden age of Armenian literature in France, the Parisbased Diaspora writer Krikor Beledian, is now read more in Armenia than in his own adopted country.

True, the Armenian press in France has always been remarkably lively and never stopped making its voice heard by matching its standards to those of the rich media landscape of France. However, none of today's press media seems to be able to face up to the challenge that an intellectual such as Shavarsh Missakian so brilliantly met in his days - to look everywhere for material that can benefit his people. Whether they are activist publications or critical Armenophile reviews, all of them validate the thesis of an intellectual weakness/ as well as of serious deficiencies in the workings of identity transmission. This does not mean to say that Armenians of France have become stupid in their 90 years of existence, but that the lack of transmission and under-investment in educational structures have generated a lasting fracture between two spaces: on the one hand a psychological ghetto where speaking Armenian is flaunted as some sort of eternal relic, or even fetish, and on the other, sharp minds cut off from the essential legacy of their elders, incapable of putting their mark on any tradition other than French-centred.

We are thus brought back to the central issue of the essential identity factor: language. But which language are we talking about? About a Westernized, standardized Armenian expurgated from the flavours of human experience, or an outgoing new language unafraid of testifying to the vibrant cultural wealth of a millennia-old nation in uprooted circumstances? One thing is sure: this troubled relation to the fundamentals of Armenian thought, which can never be reduced to one traumatic memory of the Genocide, keeps perpetuating frozen-in-time folklore, stereotypes and icons (cooking, traditional dances, Ararat and Aznavour), while some reinvigorating works of our literary heritage (Oshagan, Indra...) are collecting dust on the bookshelves of Armenian cultural centres for want of translators and readers.

For a re-examination of transmission mechanisms

This bitter state of things is compounded by the startling indifference of the 18 to 25-year-old age group to the very complete curriculum offered by the Department of Armenian studies at the prestigious Oriental languages school INALCO – the sole university in Europe and maybe in the entire Diaspora to offer such a range of courses towards professional specialization. And what to say of the feeble response to the innovative proj-

ect of educational modules "Digital Armenian Campus" of the Sources d'Arménie association? For their part, a few book publishers (such as Parenthèse, Sigest, Éditions Thadée, le Cercle des écrits causasiens), who provide commendable non-profit support to Armenian literature, are a comforting antithesis to the grotesque TOROS Prize set up in Marseille to honour "star writers" in a bling and glitzy ceremony.

Clearly, the true stake of developing Armenian identity lies in part on teaching a new elite who can simultaneously address the Armenian and French audiences, a perfectly bilingual elite who is integrated in both cultural spheres so as to decipher the complexity of our reality and make stimulating sense of our diasporic experience. Besides, a policy of aid to literary and cinematographic creative works could give birth to a new movement within the Diaspora dealing with essential themes (sexuality, intercommunity mixing, figuration of Turks yesterday and today, identity fragmentation, etc.) These new vistas would enable us to widen the borders of an Armenian mindscape traditionally confined within local limits with a poor representation of contemporary Armenia - a little known country and source of many frustrations even though Yerevan is only a 4-hour flight away from Europe. Without a grasp on his past or present history, the Armenian of France lives in a permanent scene of shambles. Both a blessing and a burden, it is a curious, specific paradox. Suffering from a lack of vision and collective project creating perspectives, he is not aware of the perverse and stifling effects of the "allcommemorative" excess. Therefore, his rebirth can only happen by way of creativity and a complete reclaiming of his legacy through the mechanisms of transmission and communication - the first step towards building a viable alternative to both assimilation and communalism.

The Talalyan Bros Festival Celebrates Jubilees of Composers Armen Smbatyan, Tigran Mansouryan and the Yerevan State Conservatory after Komitas

On June 25th at the Yerevan Komitas Chamber Music Hall 5th concert of the Geronty and Henrik Talalyans festival 2014 was dedicated to the 60th jubilee of *Armen Smbatyan*, 75th jubilee of *Tigran Mansouryan* and the 90th anniversary of the Yerevan State Conservatory after Komitas.

Naturally, the concert program consisted of works by the two composers.

In the first half the jam-packed audience enjoyed Smbatyan's "Variations for

Piano", also Mansouryan's "Oror" ("Lullaby", dedicated to the memory of Russian Prince *Andrey Volkonsy*) performed by young, but already well-known pianist *Julietta Vardanyan* as well as "Ode to Lotus" by Mansouryan for alt played by *Yana Daryan*, also - Smbatyan's "Chakona and Fugue" for piano performed by Julietta Vardanyan, *Karen Shahgaldyan* (violin) and

the Honored Artist of Armenia, Associate Professor of the Conservatory, the Festival Founder and Artistic Director Aram Talalyan (cello).

In the break of the concert your author asked composer *Daniel Erajisht* (Grigor Danielyan) about his impressions:

- The first word that I will say - it was interesting from the point of view of the composer's inner world, so what is going on in his soul... Armen Smbatyan's Trio's (Chakona and Fugue) first part seemed to me more tragic, i.e. revelations, while in the second part the motive was rising as a wave, and then again came back to a more tranquil, meditative process.

But, nevertheless, the inner struggle remains until the very end ...

- ... I am far from certain professional judgment which, today, unfortunately, is a common temptation, but I thought I heard "Kroonk"'s (The Crane) melody ...

- Yes, you are right. "Kroonk" was there, and also a kind of a sigh - of our spirituals hymns, sharakans ...

As for the Mansouryan's "Lullaby", it was very beautiful, light like air itself, and then it disappeared in the upper registers as a recollection...

- Once again sorry for the comments, but Armen Smbatyan's "Variations..." reminded me Arno Babajanyan's handwriting ...

- Of course, there was the same method, of *Arnold Schoenberg*, which so brilliantly, first among Armenian composers, apply great Arno, and, importantly, another Armenian composer, Armen Smbatyan continued and developed it ...

In Conservatory Professor, composer *Michael Kokjaev's* words, traditionally, we are admired by every new piece by outstanding Tigran Mansouryan, so there is no surprise here...

As for Smbatyan's works, Professor







Kokjaev said that, unfortunately, he was not previously familiar with the Trio, and it became a pleasant surprise for him. "A good "drive" was there, and it was a mature work", he said.

Kokjaev emphasized the fact that, being an Ambassador, public figure, Chairman of the Board of Trustees of the Conservatory, composer Armen Smbatyan surprisingly finds time to write music:

"Generally, it is an excellent musical family: patriarch of Armenian musical pedagogy Tatyana B. Hayrapetyan, her son Armen Smbatyan, and, finally, grandson Sergey Smbatyan who founded a Youth Orchestra (currently the State Youth Orchestra of Armenia, SYOA) when was 19 years old only, which - I'm saying this with all responsibility - works excellent ..."

In the second half of the concert the SYOA, this time conducted by Aram Talalyan, performed "Magaghat" (ancient

Armenian manuscript) symphony for strings by Smbatyan and Mansouryan's N 1 Fantasy for Piano and Strings.

Who would be asked to comment a work having name "Magaghat", if not, again, Daniel Erajisht, the Founder of "Sharakan" ensemble of Armenian medieval/spiritual music? He said:

"Not often the name of a work corresponds to the content, but this is exactly the case. The author used, in particular, in the arrangement, Armenian medieval tunes, I noticed combination of static and dynamic states, so it was a successful combination of past and present.

Bas piccikato made me imagining a march through the Ages ..."

In his brief interview with your author Maestro Tigran Mansouryan said: "... I'm really impressed very much indeed, I am very grateful to Aram Talalyan, soloists, the Youth Orchestra for this wonderful evening. Again, thanks a lot...".

Unfortunately, another "Hero of the Day", Armen Smbatyan was unable to attend the concert

because of being forced to urgently travel abroad, and his Congratulatory Letter that minutes before was given to a living legend Maestro Tigran Mansouryan, was handed over to the Ambassador A. Smbatyan's son, Sergey Smbatyan.


